St. Louis Volunteer Lawyers and Accountants for the Arts (VLAA) supports the creative community by providing free legal and accounting assistance and a wide variety of affordable educational programs. We serve artists of every discipline and career level, nonprofit cultural organizations and small arts-related businesses. Our organization enhances the region's cultural fabric and offers rewarding volunteer opportunities. In our quiet way, working case by case, St. Louis Volunteer Lawyers and Accountants for the Arts (VLAA) connects the creative community with lawyers and accountants who share our belief that success in the arts should depend on creative energy and talent, not on the ability to afford professional services.

Because familiarity with arts law and business practices can help avoid legal and accounting problems, we offer workshops, publish free guides, operate a speakers' bureau and maintain a content-rich website. The goal is to ensure artists and arts administrators understand their legal rights and responsibilities and the importance of sound business practices.

New Initiatives

TAX PREPARATION CLINIC

Thanks to a new partnership with Gateway EITC Community Coalition, we offered free tax preparation services to the residents of Metropolitan Artist Lofts and Leather Trades Artist Lofts in 2013. Both properties provide affordable housing for artists. "Everything was quick and painless," said artist Matt Bloomberg. "Best tax experience ever." Gateway EITC volunteer Lucas Gredell is a portfolio financial analyst at U.S. Bank.

STREET PERFORMERS

In 2012, following numerous complaints about a drum line that was performing in several locations in the City of St. Louis, the cost of an annual street performer permit was raised from \$25 to \$100. In addition, performers seeking permits were required to audition. With the assistance of the American Civil Liberties Union of Missouri, Nick Pence and Frederick Walker filed suit in federal court in May 2013. Citing the First Amendment, Judge Catherine D. Perry granted a preliminary injunction indicating that she believed the musicians were likely to succeed on the merits of their case. Rather than purse further legal action, the Board of Aldermen repealed the city's street performer ordinance in October. We supported the musicians' lawsuit, organized an open meeting for street performers and are helping them draft voluntary best practices guidelines.

EVERY ARTIST INSURED

For artists, like Andra and Hudson Harkins, the challenges of obtaining and maintaining health insurance coverage often are exacerbated by their relatively low incomes, episodic work and high rates of self- and part-time employment. The couple (and many others) attended one of our lectures explaining the Affordable Care Act. Then they received one-on-one enrollment assistance provided by certified enrollment counselor James Bellamy. Since October 2013, we've sponsored six free info sessions, co-hosted four enrollment sessions with the Community Action Agency of St. Louis County, provided access to easy-to-understand online information, produced short videos highlighting artist stories and distributed an artist-friendly infographic. Our Every Artist Insured campaign is made possible by grant support from the Regional Arts Commission.

Sculptor John Medwedeff of Murphysboro, Ill., was embroiled in an ugly dispute with the city of Murphysboro over his design of a park, including the band shell, above, when he called us in 2012. Thanks to the assistance of a team of Bryan Cave volunteers, he recently received a \$50,000 settlement. "Getting excellent legal representation in a complicated case that would have ended my studio business felt like winning the lottery," said Medwedeff. "The lawyers at Bryan Cave are dedicated and awesome."

Accountants and attorneys volunteer their time for many reasons: to deepen their experience in an area of law or business that interests them, because of their own artistic experience or aspirations, because an artist friend or family member has exposed them to the legal and accounting needs of the artistic community, or simply because they enjoy the arts and appreciate the richness arts adds to our lives. Last year, our volunteers donated more than \$100,000 in pro bono services to Missouri and Southwestern Illinois clients.

They answer questions about copyright and draft contracts and leases. They file tax returns and set up bookkeeping systems. Their work strengthens our vibrant arts community.

FOR ARTS ORGANIZATIONS

We offered hands-on QuickBooks training, which was once again presented by Rebecca Gorski and Katie King, Anders CPAS + Advisors, at Webster University's downtown campus. Our ever-popular Accidental Arts Administrator was presented in the fall and spring. It provides basic training in arts management. Accidental Arts Administrator is team-taught by staff members from Arts and Education Council, Missouri Arts Council, Regional Arts Commission and VLAA.

FOR ARTISTS

Our Business Edge seminar series assists the region's individual artists plan and sustain creative careers. In all, ten sessions were offered. Ten members of Saint Louis University's Intellectual Property Association attended our Copyright Clinic on April 8. The program began with a copyright basics lecture presented by 3L Andy Primm. Then nine volunteers, including David Koonce, met one-on-one with artists. "The copyright clinic was a great experience," said Ashley Sproull. "As an upcoming lawyer, I was able to observe actual intellectual property attorneys give real-world advice to local artists and business people and learn how to approach copyright issues when giving advice to clients. It was very exciting," she said.

FOR STUDENTS

By providing guest speakers, including twelve working artists; free easyto-understand guides on copyright, contracts and taxes; and workshops in negotiation skills (introduced last year), we're helping students make the transition from the academic environment to their artistic careers. During 2013, we made 42 presentations reaching 915 students.
