Get My Payment

This IRS tool allows you to check on the status of your stimulus payment. Also, If you already filed 2019 taxes, but did NOT provide direct deposit information, or provided direct debit information for a tax payment, you can update direct deposit information here so long as your stimulus payment has not already been processed. <u>https://www.irs.gov/coronavirus/get-my-payment</u>

Non-Filer Tool

This IRS tool is for those who are not required to file taxes, and did not file 2018 or 2019 taxes. It lets the IRS know about family size, address, or banking information for direct deposit of the stimulus check. <u>https://www.irs.gov/coronavirus/non-filers-enter-payment-info-here</u>

IRS Free File

This IRS tool allows you to find a free, online, self-prepared tax service. This tool should be used if you are required to file taxes for 2019. In most cases the services provide a free federal return only. <u>https://www.irs.gov/filing/free-file-do-your-federal-taxes-for-free</u>

Stimulus Delays & 3rd Party Tax Preparers

There have been delays reported by taxpayers who used 3rd party services to file their taxes and took advantage of services like refund anticipation loans or other programs that use the refund to pay for the service. The delay is caused by the IRS not having taxpayer direct deposit information, but the tax service bank information. This results in the stimulus mistakenly going to the tax service bank, then being rejected, and forcing the IRS to send a paper check to the address on file.

Tips to Avoid Scams

- The IRS will not call, text, or email you.
- Hang up on robocalls, don't press any numbers or talk with anyone.
- The FDA has no proof herbal remedies, essential oils, colloidal silver, or other homeopathic treatments are effective at treating, curing, or preventing COVID-19.
- Don't click on links in emails or text messages, even if they look like they are from legitimate sources, unless you specifically requested the information. Go to the source website and seek assistance there if you have questions.
- Use a credit card when shopping online and research new online stores.
- Avoid donating to charities that ask for donations of gift cards, wire transfers, or cash.
